

- Persons WITH DUAL citizenship, ONE of which IS Canadian, must apply WITH their Canadian passports only. Applicants WITH other THAN Canadian passports must provide the copy of the document confirming their current resident STATUS IN Canada (PR Card, Landed Document, WORK Permit)

1. Non-Canadian applicants are subject to \$75.00 additional fee, longer processing timings and must submit a full copy of last month bank statement.

2. Non-Canadian applicants married to Egyptian citizen receive visas in standard processing timing.

3. Canadian passport holders traveling as tourists do NOT need a visa if they arrive by air <u>DIRECTLY</u> at Sharm El Sheik (SSH), Saint Catherine (SKV) or Taba (TCP) airports and <u>remaining in the Sinai resorts ONLY</u> and their stay does not exceed <u>15 calendar</u> <u>days</u>.
