- Persons of <u>Indian origin (born in India) or Pakistani</u> origin even if they hold Canadian or other passport as well as <u>Bangladesh</u> passport holders must apply in person to the Indian High Commission directly.

 - For teaching jobs, Letter of appointment from the school and no-objection from the Ministry of Human Resources and Development, New Delhi.
 - For Pilots, a letter of clearance from Directorate General of Civil Aviation.
