The world unfortunately is not a safe place. When you travel abroad and surrounded by foreign environment many situations, in some cases hostile may arise, like terrorist attacks, banditry or even war. Plus there are natural disasters and catastrophes.

Please note that photos from photo booth or home-shot photos are not acceptable. Female applicants age nine and up are requested to respect Islamic dress code.
- Reference number of the letter of invitation (Visa Authorization Code).

Important Notes:

1. When you request this letter please make sure that it is sent to the Iranian Embassy in Washington DC only.
 2. The reference number is valid for only 3 months from the issue date.
- **Minors applying for Iranian visa** must provide additionally:
 - A letter from the minor's father permitting the minor to travel to Iran. (If the father is absent a notarized permission from the child's legal guardian is required).
 - A copy of the first 2 pages of father's passport.
 - A copy of the first 2 pages of mother's passport.
 - A copy of the parent's marriage license.
 - Note: Fees indicated are for Canadian passport holders only.
 - Persons WITH DUAL citizenship, ONE of which IS Canadian, must apply WITH their Canadian passports only.
